general information:

Client provides camera ready art and will place a **minimum order of 48 units per design/color** (sizes can be mixed)

design fee:

\$75 (this is a one time charge for screens and art preparation including size scaling when necessary for the various t-shirt sizes and the cost of producing the first sample for approval and color match) This fee also includes one re-color if necessary.

production costs:

1 color design: **\$25.00*** setup fee + **\$9.00** per unit

2 color design: **\$50.00*** setup fee + **\$9.50** per unit

3 color design: **\$75.00*** setup fee + **\$10.00** per unit

Rhinestones: **.50** each

*for orders of 200 units or more (of the same design and print/thread color) the setup fee is waived.

** 48 unit minimum and setup fees will apply to all reorders.

schedule:

design: 1-2 weeks from the time original art is received for submittal of artwork/sample by I See Spot to client for pre-production approval.

production: 1-2 weeks after final design approval.

Terms & Conditions

i see spot

1. Payment

Initial payment of 50% is needed to commence work, full remainder due upon completion of order.

2. Changes

The Client shall be responsible for making additional payments for changes requested by the Client to the original assignment.

3. Cancellation

In the event of cancellation of this assignment, ownership of original artwork shall be retained by I See Spot, and a cancellation fee for work completed, based on the contract price and expenses already incurred, shall be paid by the Client.

4. Modifications

Modification of the Agreement must be written, except that the invoice may include, and the Client shall pay, fees or expenses that were orally authorized in order to progress promptly with the work.

5. Confidential Information

I See Spot acknowledges and agrees that the source materials and marketing plans or other sensitive business information, as specified by the Client, including all materials containing said information, which are supplied by the Client to I See Spot or developed by I See Spot in the course of developing design materials are to be considered confidential information. Information shall not be considered confidential if it is already publicly known through no act of I See Spot.

6. Ownership and return of Artwork

I See Spot retains ownership of all original artwork, whether preliminary or final. The Client waives the right to challenge the validity of I See Spot design ownership of the art subject to this agreement because of any change or evolution of the law and will return all artwork within thirty (30) days of use to I See Spot.

7. Warranty of Originality

The Client warrants and represents that, to the best of his/her knowledge, the work assigned to I See Spot hereunder is original and has not been previously published, or that consent to use has been obtained by Client on an unlimited basis; that all work or portions thereof obtained through the undersigned from third parties is original or, if previously published, that consent to use has been obtained on an unlimited basis; that I See Spot has full authority to make this agreement; and that the work prepared by I See Spot does not contain any scandalous, libelous, or unlawful matter. This warranty does not extend to any uses that the Client or others may make of the I See Spot product which may infringe on the rights of others. The Client expressly agrees that it will hold I See Spot harmless for all liability caused by the Client's use of I See Spot design product to the extent such use infringes on the rights of others.

8. Acceptance of Terms
